- 5. Receive financial report from District's Bookkeeper and consider:
  - a. approval of payment of bills and invoices; and
  - b. approval of financial report.
- 6. Receive report from the District's General Manager regarding proposed plan to finance District improvements and plan for implementation as well as financial matters, utility planning and service issues, water supply evaluation and management.
- 7. Discuss and consider approval of Interlocal Agreement with Midland County for use of County right-of-way.
- 8. Discuss and consider approval of Interlocal Agreement with Midland County for maintenance of Vander Ranch streets and roads.
- 9. Discuss and consider approval of agreement with Oncor for Street Lighting.
- 10. Discuss and consider approval of agreements with Vander Ranch Homeowner's Association related to:
  - a. Street Maintenance; and
  - b. Street Lighting.
- 11. Discuss and consider status of Regional Water and Sewer agreement for Vander Ranch Subdivision area.

- 12. Discuss and consider status of Interlocal with the City of Midland, Midland County and Midland County Fresh Water Supply District No. 1.
- 13. Discuss and consider adoption of the tax and budget planning calendar for 2021 and take any related action.
- 14. Discuss and consider update to TCEQ District Registration Form.
- 15. Discuss and consider adoption of new procedure for posting notice of future executive session items.
- 16. Receive report from District's attorney regarding contracts, legislative issues, regulatory issues and matters relating to future elections.
